Smoke ventilation allows the creation of a smoke free layer above the floor by removing smoke. This improves the conditions for safe escape and permits the fire to be fought in its early stages.

Tested to EN12101-2-2003, the TOTAL70 AOV using the SE CONTROLS actuator meets the stringent requirements of opening and closing the window, which inaddition has been rigorously cycle tested for reliability and operation at 300° in accordance to EN12101-2-2003.

- 70mm system depth
- 105.5mm T Sash
- 72mm Outer Frame
- Open out windows
- 28mm glazing unit

The TOTAL70 AOV is based on REHAU TOTAL70 system. The system uses the SE actuator utilizing both the reinforced 105.5mm T Sash and 72mm Outer Frame with the sealed unit utilizing glazing clips.

## Glazing

Glass units must be double glazed using 6 x 6mm toughened glass made into a 28mm unit with an aluminium spacer.

# Reinforcement

All profiles, irrespective of size, must be reinforced. Manufacturing details must be strictly followed.
